**Role title:** Outdoor Learning Tutor

### Overall purpose of role

To lead inspiring nature-based outdoor learning programmes for school groups, working with some or all of the following key stages: reception, KS1, KS2, KS3 science and KS5 biology.

- Leading excellent outdoor learning sessions for visiting school groups.
- Following programme outlines, adapting these for learners' needs, teacher requests, weather conditions and the outdoor environment.
- Setting up and packing away equipment.
